**TESTS:** Green as Grass - ADS Training Test 1, Training - ADS Training Test 2, Preliminary -ADS Preliminary Test 2, Intermediate -ADS Intermediate Test 3, Advanced Test of Choice (please specify) Extra Cones rounds or Dressage only also offered. For "Dressage only" please specify test. Cones available to school Saturday. You must bring a spotter and leave the course intact. Distance will be set at 160 cm.

**FEES:** Combined Test (1 dressage test/1 cones rounds) - \$25; Dressage tests - \$20; Cones - \$10 per round. Late entries accepted if space is available - \$30 late fee applies.

**REFUNDS:** Checks held until MONDAY after the show. Weather cancellations announced by noon FRIDAY (call 910-875-4814). In the event of show cancellation, checks will be destroyed. No refunds after closing date except for weather related cancellation. Draw checks to Moore County Driving Club.

I hereby release, waive and forever discharge The Moore County Driving Club, their officers, directors, employees, volunteers, and agents and the owners and operators of Big Sky Farm, from any and all claims, demands, actions and rights of action of whatever kind or nature, in law or in equity, know or unknown, arising from or related to any bodily or personal injuries, death or property damage arising from or related to the horse related activity conducted by The Moore County Driving Club.

Moore County Driving Club strongly encourages the use of protective equipment. I am acquainted with appropriate equestrian safety practices. It is not the responsibility or obligation of The Moore County Driving Club to teach or advise me of appropriate equestrian safety practices.

This Assumption of Risk, Hold Harmless and Waiver is given on behalf of me, my spouse, legal representatives, administrators, executors, heirs, assigns and any child of whom I am a parent or guardian, their legal representatives, administrators, executors, heirs and assigns.

If any portion of this Assumption of Risk, Hold Harmless and Waiver is held to be invalid by any court or other governing body, the remainder shall continue in full force and effect.
